I hope this helps you better understand the plans for the Alien Stock Festival.

- 1. I will send you the map shortly as an attachment. Also, since 's property is in question; what if it is only used for either overflow parking or a temporary impound yard (for a fee, of course)? But that would be between and Tow company just a thought.
- Parking along the frontage road will be the South side of Hwy 375 and after the drainage ditch. This areas intended use is for Self-Contained RV and Media Parking.
- 3. Music doesn't start until 8pm on Friday, so it will be shut down by 2am. This also allows for clean-up and down time. And there will be music from noon to 2am on the 20th and 21st, with downtime in between.
- 4. We do not not intend for any roads to be closed in the town of Rachel. However; if we could block the main entry from the highway in front of the Little A'le' Inn, this would allow us to control access to parking easier with little confusion for Parking Staff and Traffic Control, as well as folks coming to this event.
- 5. Everything within the event will be self powered ie: Generators NOT FROM THE POWER GRID. I intend to rent at least two 5,000 watt Generators for the use of some of the Vendors so we don't have 20 small generators running at the same time. No one will be allowed to plug into Lincoln County Power for any reason whatsoever.
- 6. All vendor information will be put up on the website <u>alienstockparking.com</u> which is the Little A'le' Inn's, and <u>alienstockfestival.com</u> which is Matty's (and The Hidden Sound LLC's). We will also put the temporary business license application information, hopefully they will be able to print it out and return it to your office. At this time we are weeding through them as we don't want too many of one type of vendor. As you know, I have invited all of the LINCOLN COUNTY Food Trucks to be here, so as of right now I only have the Taco Truck from Panaca locked down.
- 7. Trash bins will be ordered this week 2 30 ft. Roll-off bins I also have plans to staff clean up crews throughout all parking and of course The Main Event area.

- 8. WE are planning Security and Medical staffing is going to be based on 10,000 attendees. One officer per 100 attendees will be on site. What this means is 3-4 teams of paramedics (2 per team) plus possibly a Doctor on site. Some of the Paramedics would be roaming while some would be stationary.
- 30 port-a-johns have already been ordered to be placed in both parking and camping areas; a total of 100 port-a-johns on site, 6 of them will be Handicap stalls.
- 10. Medical staff; Guardian Elite Medical Services: 702-436-7911
- 11. Free water station will be set up from my well; Davis Drilling is assisting in the manifold and pressure tank installation.
- 12. I have secured a semi-truck (refrigerated) one half full of bottled water, the other half full of ice for the weekend event. If we run low, there will be a back-up truck on standby for delivery.
- 13. Little Ale Inn has special Event Insurance of \$1,000,000 as required by Lincoln County, we have also made sure that Lincoln County is on the policy. Policy is in the hands of Dolan & Edwards of Caliente, Nevada. I also have required that The Hidden Sound LLC have a 10 million dollar insurance policy, which includes Bad Acts Coverage.
- 14. Internet will be provided for vendor use only.
